

# Apply for parking relief for severely disabled people - Orange parking permit

Severely disabled people who have received a positive certificate for special groups from the Bremen Office for Care and Integration can apply for an orange parking permit.

#### **Basic information**

Holders of the exemption permit have the following authorizations (provided there is no other parking option within a reasonable distance):

- Parking for up to three hours: in places where there is a restricted stopping ban (the arrival time must be shown on a parking disk)
- Exceeding the permitted parking time: in the area of a no-parking zone
- Parking beyond the permitted time: in places where parking is permitted but the parking time is limited by an additional sign
- Parking during loading times: in pedestrian areas where loading and unloading is permitted for certain times
- Parking for up to three hours: in parking spaces for residents
- Parking without charge and time limit: at parking meters and parking ticket machines
- Parking in designated traffic-calmed areas: outside the marked parking spaces provided that other traffic (in particular moving traffic) is not disproportionately affected

The maximum permitted parking time of 24 hours may not be exceeded.

## Requirements

The orange parking permit can be applied for if one of the following conditions is met:

- severely disabled with the G and B signs and a degree of disability of at least 70 for functional disorders of the lower limbs alone (and the lumbar spine, insofar as this affects the ability to walk) and at the same time a degree of disability of at least 50 for functional disorders of the heart and respiratory organs
- severely disabled with Crohn's disease or ulcerative colitis if the degree of disability is at least 60
- severely disabled with an artificial anus and simultaneous artificial urinary diversion, if the degree of disability is at least 70
- an exemption may also be granted to those severely disabled persons who, according to a medical assessment, are equivalent to the aforementioned group of persons.

#### What documents do I need?

- Certificate for special groups from the Office for Care and Integration Bremen
  - When officially applying for a severely disabled person's pass, this parking facilitation will be checked immediately if the "aG" mark has been ticked in the application. Otherwise, please send an informal letter requesting a review or call the AVIB to request approval.
- We require the following documents for applications for third parties:
  - Documents of the applicant, certificate for special groups from the Office for Care and Integration Bremen Versorgungsamt
  - Power of attorney from the applicant
  - If applicable, care certificate

## **Procedure**

- An application can be submitted in writing by e-mail or by post and online.
- If the exemption is extended, the documents must be submitted again if the certificate for special groups has been issued for a limited period.
- The application must be submitted by the legal representative for a child or a person with legal custody

#### More information

The exemption is valid throughout Germany.

It is not permitted to park in parking spaces with the wheelchair symbol with this special permit. Parking permits for these parking spaces are issued to severely disabled people with exceptional walking disabilities, bilateral amelia or phocomelia or with comparable functional impairments as well as blind people (see General parking facilitation for people with disabilities, characteristics aG (exceptionally disabled) or BI (blind)).

## What deadlines must be paid attention to?

The exemption is granted for a maximum of five years and is revocable at any time. In the case of a temporary certificate for special groups, until the expiry date.

The exemption can be extended after the expiry date if the conditions are still met.
